

RESOLUTION NO. 20-10

**Oregon State University
Student Incidental Fees
Fall 2020**

Whereas, the Board of Trustees of the Oregon State University (the "Board") has the authority to determine tuition and mandatory enrollment fees in accordance with ORS 352.102 and ORS 352.105, and other applicable law;

Whereas, the Board authorizes the collection of incidental fees recommended by the President of the University and the recognized student governments (ASOSU and ASCC) and established in accordance with provisions outlined in ORS 352.102, ORS 352.105, and other applicable law;

Whereas, student services at OSU campuses and centers will continue to be offered during fall term, as a mix of in person and online delivery, but some services will be reduced in scope or capacity consistent with the university's COVID-19 resumption plan approved by the Board on August 14, 2020;

Whereas, in coordination with the Associated Students of OSU (ASOSU) and the Associated Students of Cascades Campus (ASCC), the President proposes that the Board grant the ASOSU and ASCC requests for revised incidental fees for fall term, recognizing the variable service levels being provided to students while maintaining support for essential student health services and other programs and the ability for programs to return to full service at the end of the pandemic; and

Now, therefore, the Board of Trustees of Oregon State University hereby approves adjustments to the incidental fees for fall 2020 as specified in Exhibit A.

This Resolution is effective October 16, 2020.
