"Resolution to Request Tution Freeze for FY 2017/2018"

- WHEREAS, students bear the immense finanical burden of Oregon State University's cost of attendance.
- WHEREAS, the rising cost of tution has surpassed inflation rates;
- **WHEREAS**, tuition has consistently increased at Oregon State University every year for the past 10 years;
- WHEREAS, some university units do not maintain the highest fiscal responsibility;
- WHEREAS, a tution freeze would encourage units to critically reevalute their spending as it relates to the mission of Oregon State University;
- WHEREAS, tuition increases disproportionaly affects economically disadvantaged groups of people at Oregon State University;
- WHEREAS, tuition is not the only finaincial impact required to attend Oregon State University;
- WHEREAS, cost of housing, utilities, books and supplies, food, transportation, and health related spendings are already a significant financial burden for students at Oregon State University;

BE IT HEREBY RESOLVED BY THE ASOSU THAT:

The Oregon State University Board of Trustees votes in opposition of tuition scenario B. Residential/Non-residential: 4%/2%, C. Residential/Non-residential: 5%/2%, D. Residential/Non-residential: 6%/2%, and E. Residential/Non-residential: 8%/2%. Instead, the Oregon State University Board of Trustees vote in favor of tuition scenario A. Resident/Non-resident: 0%/0%.
